## ANNUAL TOWNSHIP TAX LEVY ORDINANCE

An ordinance levying taxes for all town purposes for Green Garden Township, Will County, Illinois, for the tax year 2022 collectible in 2023.

BE IT ORDAINED by the Board of Trustees of <u>Green Garden</u> Township, <u>Will</u> County, Illinois, as follows:

SECTION 1: That the sum of <u>Two Hundred Eighty-three Thousand One Hundred Seventy-five</u> Dollars (\$283,175) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund and General Assistance Fund for the year 2022.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
