TAX LEVY ORDINANCE

ORDINANCE # RB-2022-02 2027 DEC 16 AM 8:51

An ordinance levying taxes for all town purposes for <u>Green Garden</u> Township Road District, <u>Will</u> County, Illinois, for the tax year <u>2022</u> collectable in <u>2023</u>.

BE IT ORDAINED by the Board of Trustees of <u>Green Garden</u> Township, <u>Will</u> County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of <u>Green Garden</u> Township Road District <u>on</u> <u>December 12, 2022</u> does hereby determine and declare that the sum of <u>Nine Hundred Sixty-four</u> <u>Thousand Three Hundred Thirty-nine</u> Dollars (<u>\$964,339</u>) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

Road & Bridge, Building & Equipment, and Joint County Bridge for the year 2022.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
