ORDINANCE # TF-2023-02

An ordinance levying taxes for all town purposes for Green Garden Township, Will County, Illinois, for the tax year 2023 collectible in 2024.

BE IT ORDAINED by the Board of Trustees of Green Garden Township, Will County, Illinois, as follows:

SECTION 1: That the sum of Two Hundred Seventy-seven Thousand One Hundred Eight Dollars (\$277,108) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund for the year 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
