An ordinance levying taxes for all town purposes for <u>Green Garden Township</u>, <u>Will County</u>, Illinois, for the tax year <u>2023</u> collectible in <u>2024</u>.

BE IT ORDAINED by the Board of Trustees of <u>Green Garden</u> Township, <u>Will</u> County, Illinois, as follows:

SECTION 1: That the sum of <u>Two Hundred Seventy-seven Thousand One Hundred Eight</u>
Dollars (<u>\$277,108</u>) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund for the year 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

II. The corporate and special purpose property taxes extended or abated for 2022 were \$256,909.

The proposed corporate and special purpose property taxes to be levied for 2023 are \$277,108. This represents a 7.86% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2022 were \$0.

The estimated property taxes to be levied for debt service and public building commission leases for 2023 are \$0. This represents a 0% increase over the previous year.

IV. The total property taxes extended or abated for 2022 were \$277,108.

The proposed corporate and special purpose property taxes to be levied for 2023 are \$943,731. This represents a 7.90% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2022 were \$0.

The estimated property taxes to be levied for debt service and public building commission leases for 2023 are \$0. This represents a 0% increase over the previous year.

IV. The total property taxes extended or abated for 2022 were \$874,648.

The estimated total property taxes to be levied for 2023 are \$943,731. This represents a 7.90% increase over the previous year.
