An ordinance levying taxes for all town purposes for <u>Green Garden</u> Township Road District, <u>Will</u> County, Illinois, for the tax year <u>2023</u> collectable in <u>2024</u>.

BE IT ORDAINED by the Board of Trustees of **Green Garden** Township, **Will** County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of <u>Green Garden</u> Township Road District <u>on</u>

<u>December 11, 2023</u> does hereby determine and declare that the sum of <u>Nine Hundred Forty-three</u>

<u>Thousand Seven Hundred Thirty-one</u> Dollars (<u>\$943,731</u>) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

Road & Bridge, Building & Equipment, and Joint County Bridge for the year 2023.
