

TAX LEVY ORDINANCE ROAD DISTRICT

ORDINANCE # RB-2023-02

An ordinance levying taxes for all town purposes for Green Garden Township Road District, Will County, Illinois, for the tax year 2023 collectable in 2024.

BE IT ORDAINED by the Board of Trustees of Green Garden Township, Will County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Green Garden Township Road District on December 11, 2023 does hereby determine and declare that the sum of Nine Hundred Forty-three Thousand Seven Hundred Thirty-one Dollars (\$943,731) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

Road & Bridge , Building & Equipment , and Joint County Bridge for the year 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

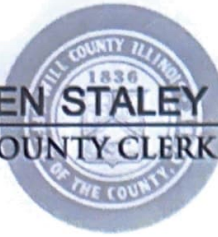



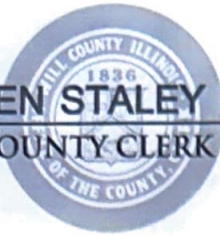
