

TAX LEVY ORDINANCE ROAD DISTRICT

ORDINANCE # 24-004

An ordinance levying taxes for all town purposes for Green Garden Township Road District, Will County, Illinois, for the tax year 2024 collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Green Garden Township, Will County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Green Garden Township Road District on December 9, 2024 does hereby determine and declare that the sum of Nine Hundred Seventy-seven Thousand Two Hundred Forty-five Dollars (\$977,245) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

Road & Bridge , Building & Equipment , and Joint County Bridge for the year 2024.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.





I. A public hearing to approve a proposed property tax levy increase for Green Garden Township -Road District Funds for 2024 will be held on December 9, 2024 at 6:45pm at the Green Garden Town Hall.

Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Bill Wagner, Trustee, PO Box 1116, Frankfort, IL 60423, (815) 530-4497.

II. The corporate and special purpose property taxes extended or abated for 2023 were \$930,710.

The proposed corporate and special purpose property taxes to be levied for 2024 are \$995,926. This represents a 7.01% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2023 were \$0.

The estimated property taxes to be levied for debt service and public building commission leases for 2024 are \$0. This represents a 0% increase over the previous year.

IV. The total property taxes extended or abated for 2023 were \$930,710.

The estimated total property taxes to be levied for 2024 are \$995,926. This represents a 7.01% increase over the previous year.
