

VA Claims Assistance

Provides assistance with claims through the Department of Veteran Affairs



Financial Assistance

Provides utility, shelter, personal needs, and/or employment related transportation assistance to qualifying veterans



Emergency Assistance

Provides assistance with coordinating local organizations and resources to address veterans emergent needs



Mental Health Coordinator

Provides onsite crisis management, brief interventions, triage services and education opportunities for Veterans and their support system.



Peer Support

Provides support for Veterans on their road to recovery by utilizing a holistic approach and real life experiences.



Homeless Veteran Prevention

Coordinates with VA and local organizations to assist veterans and their families with homeless prevention and housing



Readjustment Services

Provides eligible veterans the opportunity to meet with licensed clinicians through Federal partnerships



- The VACWC is governed by a Commission of Veteran Representatives from Veteran Service Organizations around the county: by veterans, of veterans, for veterans.
- The VACWC has Accredited Veterans Service Officers that represent Veterans from the initial claim to the Board of Veteran Appeals, if necessary.
- Veterans did not have to serve in combat to be eligible for VA compensation, pension, or healthcare.
- Vietnam Veterans no longer have to show "boots on the ground" to prove exposure to Agent Orange. There are several other locations, both stateside and worldwide, where Agent Orange was used or stored.
- Veterans benefits do not carry over to the surviving spouse upon death; however, there are other benefits spouses may qualify for.
- Qualifying Reservists and National Guardsmen can receive VA Healthcare as well as Service Connected Compensation.
- Veterans thinking about filing a claim should call 1-800-827-1000 and ask to submit an "Intent to File."
- Once the VA makes a decision, Veterans can request a review of their claim within one year, while keeping their original effective date without having to file a formal appeal.
- Veterans that qualify for VA Healthcare can go to a participating Physicians Immediate Care or Urgent Care, and receive treatment per their VA Healthcare eligibility.
- Upon admission to a private emergency room, Veterans enrolled in VA Healthcare have 72 hours to notify the VA for possible coverage. Hines: 708-202-7200

Transportation
