

**ANNUAL TOWNSHIP TAX LEVY ORDINANCE
ORDINANCE # 25-005**

WILL COUNTY CLERK
WILL COUNTY, ILLINOIS

An ordinance levying taxes for all town purposes for Green Garden Township, Will County, Illinois for the tax year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of Green Garden Township Will County, Illinois, as follow

SECTION 1: That the sum of Three Hundred One Thousand Four Hundred Dollars (\$301,400) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 2: That the amount levied for each object and purpose shall be as follows:
