An ordinance levying taxes for all town purposes for Green Garden Township Road District, Will County, Illinois, for the tax year **2025** collectable in 2026.

BE IT ORDAINED by the Board of Trustees of Green Garden Township, Will County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Green Garden Township Road District on December 8, 2025 does hereby determine and declare that the sum of One Million Twenty Six Thousand Dollars (\$1,026,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

Road & Bridge , Building & Equipment , and Joint County Bridge for the year

2025. SECTION 2: That the amount levied for each object and purpose shall be as follows:



SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Green Garden Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
